NEW DELHI, OCTOBER 3

Heavy rains lashed several parts of the Capital on Thursday evening bringing down the mercury level, officials said. Delhi recorded 35.2 mm rainfall at 8.30 PM and the temperature was recorded at 21.6 degree Celsius, a senior MeT official said.

According to the meteorological department, the maximum temperature recorded at 5.30 PM was 34.8 degree Celsius, a notch above the normal, and the minimum 23.8 degrees Celsius, two notches above nor-

mal. Humidity levels oscillated between 83 and 55 per cent. Flight operations at Delhi Airport had to be suspended for 24 minutes in the evening due to extremely heavy rains. - PTI
