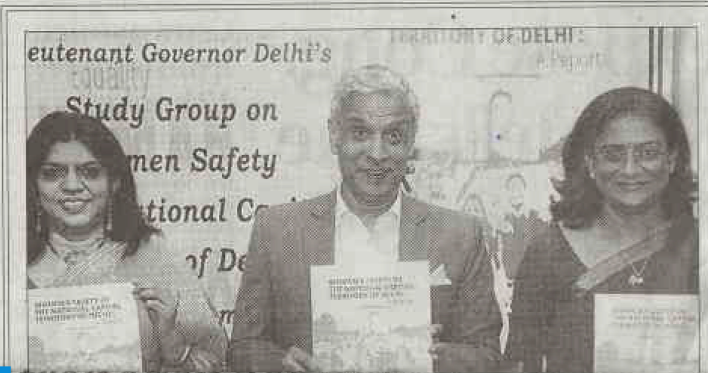

Transgender policy of Metro unveiled

The government has decided to formulate a policy for the welfare of transgender and a seven-member panel, comprising experts from the field, will be constituted in this regard.

The committee, whose names of the members will be formally shared on Monday, will submit its report within three months with recommendations on schemes and steps in the light of the landmark Supreme Court judgement to strengthen the rights of the transgender community

The committee will comprise a clinical psychologist from IBHAS, a senior social welfare official, a retired doctor from defence forces, three representatives from the section, including a doctor from Mumbai, assistant professor and a transgender and lawyer-activist Laya Vasudevan, director of the Delhi-based Centre for Legal Aid and Rights. Laya is known for her contribution in the 2014 landmark judgement of the Supreme Court that recognised transgender as the third gender
